137.01 POWERS, DUTIES AND SALARIES.

(a) As provided in the City Charter there is hereby established a Department of Public Safety-Service, consisting of a Director of Public Safety-Service who shall have the powers and duties set forth in Section 4 of Article IV of the Charter. He shall have such assistants as have heretofore or may in the future be provided by ordinance of Council.

(b) The salaries of the Director and/or assistants referred to herein shall be as now are or in the future may be fixed by ordinance of Council.

137.02 DIVISIONS WITHIN THE DEPARTMENT.

The Department of Public Safety-Service shall include the following divisions and such others as in the future may be made a part of the Department by ordinance of Council:

Police Division

Fire Division

Sewers Division

Service Division to handle the functions of streets, parks and refuse collection.

Rocky River Wastewater Treatment Plant

137.03 ADMINISTRATIVE SUPERVISION.

All Divisions so designated as part of the Department of Public Safety-Service shall be headed by a Commissioner, Chief or Superintendent who shall be appointed by the Mayor and report directly to the Director of Public Safety-Service. The Director of Public Safety-Service shall have the administrative duties and powers over all such division and as provided law.
