

APPENDIX B  
SPEED LIMITS

By virtue of the provisions of Ohio R.C. 4511.65, Council has determined and hereby declares that a safe prima-facie speed limit on those streets which are set forth herein and which is made a part hereof, is determined to be twenty-five (25) miles per hour.

Standard signs, properly posted, giving notice of such speed limit, shall be erected on such streets.
