Parks & Recreation Commission Meeting- Minutes March 10, 2022

- *Call to Order*: Meeting was called to order at 7:47am. The meeting was held in person at The Ice Rink Pavilion. Members Present: Jim Ulchaker, Joe Roszak, Amy Massad, Dave Furry. Also present: Bob Holub, Krissie Miller, Katie Blodorn, Michelle Eibel, Jason Frolo, Erica Garland
- **Approval of Minutes**: Minutes from February 10th, 2022 were approved as submitted. Amy Massad motioned and Joe Roszak 2nd.

Fees for Approval:

- **1. Aquatics**: presented by Michelle Eibel. All lifeguards are certified. American Red Cross certified with lessons
- <u>Group Swim Lessons</u>: Proposed increase of fees to Mem: \$64/ Res: \$80/ NR: \$120 for 8 week session. Motion to approve by Dave Furry, 2nd by Amy Massad.
- Private Swim Lessons: Proposed increase of fees to Mem: \$125/ Res: \$150/ NR: \$225 for 5, 30 minute lessons. Board discussed and thought it could be increased by \$5 more per lesson. Motion to amend to Mem: \$150/ Res: \$175/NR: \$250, and approved by Dave Furry, 2nd by Joe Roszak.
- -Semi Private Swim Lessons: Proposed increase of fees to Mem: \$95/ Res: \$125/ NR: \$195 for 5, 30 minute classes. Board discussed and thought if private swim lessons go up so should semi-private, by \$5 as well. Motion to amend to Mem: \$120/ Res: \$150/ NR: \$220, and approved by Dave Furry, 2nd by Joe Roszak.
- 2. Tennis: presented by Jason Frolo
- -<u>Tennis Camp and pee-wee tennis classes</u> (weekly 1.5 hr youth summer classes): proposed member rate and increase of fees to **Mem: \$65/ Res: \$75/ NR: \$80**. No previous member rate was set. **Motion to approve** by Jim Ulchaker, 2nd by Amy Massad.
- -Adult tennis (weekly 1 hr adult classes: Proposed member rate and increase fees to Mem: \$68/ Res: \$72/ NR: \$77. No previous member rate was set. Motion to approve at the same time as the youth tennis classes. 1st: J. Ulchaker, 2nd: Amy Massad.

3. Elmwood Camp 2022 - presented by Katie Blodorn

Proposed to increase dates of camp from four weeks to five weeks (June 13th- July 21st (omit week of July 4th)). Also proposed increase of fees (last increase was 2016) to **Mem: \$58/Res: \$62/NR: \$66. Motion to approve** by Amy Massad, 2nd by Jim Ulchaker.

- 4. <u>Fitness</u>: presented by Katie Blodorn
- -Adult Yoga Workshop: new 4 week workshop focusing on mindfulness through breath work and slow yoga. Fees: **Mem: \$35/ Res: \$40/ NR: \$50. Motion to approve** fees by Joe Roszak, 2nd by Jim Ulchaker.
- -<u>Youth Yoga Pop-Ups</u>: new weekend class for ages 3-8 to learn yoga through breath and movement. Fees (per class) **Mem:** \$8.50/ Res: \$9.50/ NR: \$10. Motion to approve fees by Amy Massad, 2nd by Dave Furry.



-<u>Stroller Strides</u>: (75/25 split) Tuesday and Thursday In the gym, a mom and stroller aged child have a 1 hr workout. Fees: **\$65/month unlimited**, **\$130 for 10 class pass**, **\$15 drop in**. **Motion to approve** by Amy Massad, 2nd by Dave Furry.

- Financially best month since at least 2017
- Tri City group met yesterday to discuss the Gemini, no timeline for finished work and still finding issues, so at least another year for their pool to be closed- group did not come up with a finalized plan but discussed a possible per visit compensation to Fairview or opening a specific membership for their current members. Currently we are receiving about 400-500 entries per month, 2800 since the closure. Fairview should have some answer pretty soon. Mayor wants to make sure it is not impacting our members and that the per visit admission to be higher than residents and members. Outdoor pool will not be affected by this. Discussion on going.
- Hockey- 3 of 4 of the RRYH teams that made the playoffs, won their division. Season has ended. Hockey Placements for next fall will happen at the end of March.
- Ice will be taken out on March 28th.
- New surface to replace the turf is on its second reading at Council, There will be no turf as long as new surface passes. Will be able to do multiple sports on it. Will decide what to do with turf after the ok for new floor.
- New Zamboni is also on Second reading this week at council meeting
- RFP's for Morley Park have come back, decision will be made and should be done no later than August 1st.
- RR Park bathroom are being redone, flooring, partitions and walls.
